In view of the importance of the subject, preliminary and quick estimates of State income for the years 1965-66 and 1966-67 respectively, have also been shown.

Unfortunately sufficient information for the period prior to reorganisation of States has not been available to make all the post reorganisation figures comparable with the corresponding figures of the pre-reorganisation stage.

A few statements have been added as Appendix in this issue indicating statewise comparative position in respect of some basic items of information.
