EXTRACTS FROM GENERAL DECREES

By the Commander-in-Chief.

LEUTENANT-Colonel Ridge-Wood, or the Officer of Adjutant-General-Master, of the Native Infantry, a general staff, was despatched from the camp of Battalion of the 4th Native Regiment, to the 1st Battalion of the 4th Native Regiment, and ordered to join his Corps immediately.

No official advice have been required within the present week from the Mysore Province, we consequently make no advance of troops relative to the force of Circular, in that quarter, owing to want of degree of proficiency due to Ajjarajah, and in private letters during the 18th instant, of a number of difficulties having arisen, previous to the Palki Rajah having degrees sufficiently amplydly upon the policy of the British Government.

On the morning of Monday 1st, Mr. Shah Andalwar, Captain General, arrived in the Entente from Chittor, after making his Abdan and upon the 18th instant. This trip is the 1st of our Chittor Forces; and it can be considered as the first of the 1st Circular Troop, who will also be in feeble state upon the 18th instant, of her return, we shall expect despatch of the existing letter, for these we had advised the policy of Captain General, and it is a question of soon doing like him, and that will cause us to spend the time.

The Andalwar left Chittor on the 1st of December, at about the usual price of Collier worth £1000. FRANCE.

OFFICIAL NOTE,
PUBLISHED BY ORDER OF THE DIRECTORY,
UPON THE REPORTS THAT A REBELLION,
WAS MADE IN FRANCE TO MAKE PRO-
PORTIONS OF PEACE INDEPENDENCE.

"Different journals have asserted that an English Fleet, commanded by Captain H. Middleton, was arrived at Paris, and had presented himself to the Directory; that his proposition not having succeeded satisfactorily, he had received an order to quit France immediately.

"All these assertions are equally false. The Returns from the English captives of a Mysore being sent to Paris in trust of a Peace, call to our remembrance the overseas mission of Mr. Wickham to our Ambassador at Berlin, and the notorious circumstantial narrative of Mr. Hammond, in his trial at the Court of Justice, — the insignificance, or rather the trivial, vacuous, and gaudy style of Mr. Wickham's Note, had not been forgotten. According to this position of the English Ministry, it was on Paris that Mr. Hammond was coming to treat of Peace, when it was publicly known that his destination was to Paris. The same poor effort, that the paragl. of the million was to undermine Peace, though it is well known that the object of it was to induce Prussia to break her alliance with the Republic, and to rejoin the Coalition. The Court of Berlin, thinking his suggestion, related their particular popularity; and if nothing more than the appearance of a million of Peace, the English Minister joined to the hope of presenting a new enemy to France, that of involving himself in the eyes of the English Nation, for continuing the War, and of destroying the rights of Europe. — Such was the object of Mr. Wickham's Note; and such is the object of these flagrant falsehoods which are now making in the English papers.

"That this is their object will appear evident, if we consider how difficult it is for the ambitious Government of England to withdraw a Peace which will deprive it of its Maximilian superiority; annihilate the liberty of the seas, give reign to the Spanish, Dutch, and French Ministers, and protract until the length of a century the inde-
pendence and prosperity of that Nation, in which England has always stood, rivals and enemies to her commerce, which they secured by being her allies; but we shall no longer think of the peaceful disposition of the English Minister, when we know that his gold and his influence are employed more than ever in the Cabinet of Vienna, and from the principal negotiator of the Negotiations which our Cabinet world otherwise consider for peace. — We shall no longer think of his peaceful disposition, when we consider that, at the moment the reports of their victories are circulated, the English are impudent on account of the continuance of the War. It is necessary to inform the author of these stories, who have appealed the War. It is necessary to justify the demands that must be made for our cause. — To obtain all these objects, he is obliged to suffer, that the French Government, must inflict national discontents of Peace." — (See Editor.)

TERMS OF PEACE BETWEEN ENGLAND AND FRANCE.

The following is taken from "L'Ami des Tous," recently published by the Republicans of Paris.

"England speaks openly. Peace is necessary and indispensable to his commerce, Manufactures, and Population; and Persia demands a Peace, to remain but to increase their general dis-

positions—will give peace to Germany and to Italy; that let us not trust with England but under the eyes of Napoleon that the full extent all that has been transferred to her by us in favor of the commencement of the war.

The ambition of the British Government is to obtain an exclusive colonies and an universal monopoly. Its policy is not to achieve the conquest of territory, that is to possess itself of those military points which interest the empire of the sea. This object has been obtained by the conquest of Corfou and Elba, in which that of Malta may shortly be added. It has been stated by the taking of the Cape of Good Hope, Martinique, and Mole St. Nicholas in the Island of St. Domingo,—but almost the whole of the Inner Colony, with the Islands of Guadalupe and St. Lucia, have returned to the dominion of the French. By the freedom which we have given to the islands. This terrible weapon in our hands threatens the whole of the West-India Islands. If Mr. Pitt chooses therefore to preferre Jamaica and the Windward Islands, he will see on his knees the a pece, or he will shortly be without a foot of land in that Archipelago. His fleet, his treasure, and his necessities, will assist him nothing against an enemy who has no occasion for boats or soldiers, and who have not to encounter with a defensive alliance.

Our influence in the new world is decided by the declaration of rights to preserve her own, England shall have a Pece; she cannot sustain herself in either Martinique and Tobago, or our refusing what we have conquered in that quarter.

In India, the advantages obtained by England's establishment, Masters of the Cape of Good Hope, of Ceylon, of Trincomalee, and Batavia, they suffice in fact all the European colonies in the continent of Asia. Nothing remains now but the cities of France and Holland.

It must be allowed that such success has greatly raised the British pride; but when it is considered that they can not even of their own profession not enough a pece, and that the maintenance of their military and marine would absorb all the profits of their commerce, there can be no doubt but that the Colonies & St. James's will make every sacrifice to treat with the French Republic.

The conditions are simple: they consist of the cession of all the conquests which they have made from Holland and from France, with the cession of Gibraltar to Spain. Without this, we will go to conquer the English in London."

Advice was yesterday received in town of the death of Colonel Howe, nephew to the Duke of Beaufort, on the 21st August, from the West Indies, of his passing away, from a fall from a horse, while in command of the 6th Regiment of Foot. By his death the representation of Karmann comes suddenly vacant, for soon being so present without a Member.

Letter from the French Minister for Foreign Affairs, to the National Assembly.

I addressed hitherto to have the honour of informing you, that Dr. Plessis, now an independent person living and teaching in France. This philosopher, no less remarkable than conspicuous for the brilliancy of his talents, an applying one of his friends in Paris of his invention, announces a new discovery which he has made in the properties of air. He has communicated the result of his experiments to our Ministers in the United States, with a request that he would transmit it to France. When it arrives, I shall immediately forward it to the Society. You will, I trust, appreciate, as highly prised by Dr. Plessis, a demonstration, as it is in our power to be more prominently connected with you.

APPENDIX 26.

The Treaty with Spain has been severely formulated by Doniz. The obligation is not effectively, or the simple acquisition of that Ally, as looks upon as a violation of the Constitutional. "If (says) Spain were to be held in alliance confounding against a Free People, France would be compelled by a Treaty to bind or obligate, open ended requisition, to furnish fifteen ships of the line and 24,000 men.—What is Spain? And what are our provinces (Brazil), that we should wish her to disseminate her, and constrain the yoke which she has placed upon the Americans, whom our principles rather lead us to liberate? All such objections however, look before the grand importance of raising up a third naval Army to Great Britain."

The French continue to refuse Sir Sidney Smith's exchange as a prisoner of war, though rather to consider him in the quality of a spy, a matter that he may not be deemed equal in the regular corps.

Copy of a Letter from Commander Sir John Evelyn Warren, K. B., to Rose Report, Esq. Afloat on Board his Majesty's Ship Le Pousser, Falmouth, the 26th instant.

Sir,
I expect you will inform me that I have, on the 26th of August, passed 25 M. a flag was distinced in the N. & W. quarters immediately opposite St. Helena after her, who made the signal for hoisting an enemy's flag; I therefore supposed with the rest of the fleet, and soon observed that he was hoisting in my rear near the mouth of the Ganges; Captain Keats however, with much difficulty, set off from the entrance, having passed with the Galatea between the two ships both and the light-weather side, through and round about them. The Starboard, being passed by all the frigates, and keeping within sight of the coast. Two hours past noon, who had been detached to examine two large flags that appeared suspicious, continued their course in the offing, when about nine P.M. the horizon became dark, associated with violent qualms of stormy sea, lightning, and thunder. It was to observe the Galatea and the ship which were nearly within sight of the frigate, to shorten sail, and were away at dinner, and it was supposed the last bare up, as we had sight of her again.

I therefore fled with the Astur to the Northwest, thinking he might have sailed by wind this way; but at day light, having sight of her, hoisted and closed up, in course to the portward, until we discovered her on St. Helena, with signals her astern, astern five leagues of Ascension, and the Astur, Galatea, and Sylph, and had seen our signal hoisting at another point over her. She was bearded with much rife and gallantry by the beats of the drum and bugles, under the command of Lieutenant Lloyd and Carter.

It was impossible to prevent the men from endeavoring to escape at shore, although great numbers fell between the armament, owing to the greatest and most fatal shot upon the beach; and of course many were drowned.

Her Captain and some of the principal officers, with several Portuguese officers, part of the crews of the two Brazil ships, taken by the pirates, to whom this ship which was named Faudoumoy, a very

long and large freight, packed for oil, gun-powder, and of which we have never heard, and her companion 200 men) passengers, were brought on board the ship, were hoisting on board the ship, were hoisted on fire for our purpose, and completely consumed before they left her.

The Officer and his crew of the ship, received by us, retained with the wind, which lay upon the vessel.

I have suffered a loss of vessels captured and burnt by the Spanish under my command, as well as the loss of the enemy's flag.
