Sir  
In Brigadier Douglas's last des-  
patch just printed I observe the following  
sentence - "On the 25<sup>th</sup> Colonel Walter had  
a conference with some of the rebel leaders  
who appeared inclined to lay down  
their arms, provided they obtained for  
themselves exemption from all further  
penalties, but as Mr. Money who was  
present at the interview did not consider  
that such stipulation could be entertained  
the conference was broken off and the enemy  
retreated." Brigadier Douglas has been  
misinformed. As the account here  
referred to necessarily convey a very  
erroneous impression of what took  
place, I beg distinctly to state that Col:  
Walter had no conference whatever  
with the rebels & that except myself not  
an individual with the force either directly  
or indirectly, personally or through  
an interpreter, held any communication  
whatever with a single leader or  
rebel



rebel at the conference - Colonel  
Walter was not even present  
at the interview - The first time as  
previously stated by me, I was  
accompanied only by Shadul Khan  
& the second time by Shadul Khan,  
Mr. Mackenzie & Lt. Beadon, the 2  
Gentlemen remaining behind, but  
close enough to hear - Col. Walter  
would on that occasion have accom-  
panied me as he wished to do, but  
seeing that the rebels were somewhat  
alarmed, I thought the fewer of us who  
approached them the better, & therefore

As to the latter part of the  
account, I need only add that as no  
offer was made on the part of the  
rebels, none was rejected by me - Had  
such an offer however been made  
I should certainly according to the  
terms of the amnesty which except  
leaders, have refused to entertain it

I could wish this letter  
to obtain the same publicity  
as the despatch -
