My dear Coupland,

Information has been received from Bengal that a political suspect domiciled in Faridpur under the Defence of India Act recently received a packet per book post containing an old Almanac with a letter inside and a pair of sacred threads concealed in a cavity formed by a number of pages of the Almanac being half cut out in the centre.

Sealy is of opinion that there is also the possibility of secret messages being conveyed to prisoners by the dotting or marking of letters and so forming a Code.

This procedure was resorted to in the past as a means of secret communications. As there are a number of political suspects under detention in the Jails of this Province I bring this matter to your notice and would suggest that District Officers and Superintendents of Jails be directed to examine carefully all books and printed matter sent to these men so that they may detect anything unusual or suspicious.

The prisoners detained in the Cuttack Jail frequently receive books from friends and relations.
