UNDER-SECRETARY-

Nothing definite has yet been decided. Mr. Kershaw, Financial Secretary Designate for Bihar, has been placed on special duty by His Honour the Lieutenant-Governor of Eastern Bengal and Assam with a view to making proposals for the new Secretariat, and I venture to suggest that he should be consulted as to the lines of the reply, as there is plenty of time. He is at present in Ramna, Dacca, and the file might be sent to him there.

B. A. Collins-10-2-1912.

THE Hon'ble Baou Braj Kishor Prasad proposes to ask questions at the Legislative Council meeting of the 26th February 1912 on the subject of the claims of Biharis, Uriyas Council meeting of the 26th February 1912 on the subject of the claims of Biharis, Uriyas and natives of Chota Nagpur to posts in the new Secretariat of Bihar. A copy of the questions is submitted. The number of Secretariat posts at present held by Biharis in Calcutta is so smell as to be practically negligible; I presume the same applies to Dacca. It will be necessary to send over a good many Bengali assistants from Calcutta to Bihar, their places being taken by those who can be spared from Dacca after the requirements of Assam and Bihar have been considered. What Babu Braj Kishor Prasad really wishes to know is apparently whether, after this has been done, there will be any vacancies in the Bihar Secretarist, and, if so, whether they will be notified, and applications invited from natives of the new province. We can give no definite reply on this point until we know how the cadres stand, and what vocancies, if any, are anticipated.

We may perhaps reply to VIII (b) and (c) to the effect that the claims of officers at present in the service of Government must be considered first; but that, if vacancies are found to occur in the establishment lists of the various departments of the Bihar Secretariat, they will be filled by recruitment from residents of the new province. With regard to VIII (d)—as the number of such vacancies is at present unknown, the question of the best method of securing qualified assistants has not yet arisen. [Probably the best plan would be to draw on existing Bihari and Uriya offices, and leave the heads of these offices to fill the vacancies by routine promotions or recruitment.] Any definite reply to question VIII (c) the vacancies by routine promotions or recruitment.] Any definite reply to question VIII (e) yould probably lead to a flood of applications, which should, if possible, be avoided; it might suffice to say that the head of the department concerned will make the selections as soon

as he finds it necessary to do so.
