QUESTION IN THE BIHAR AND ORISSA LEGISLATIVE COUNCIL REGARD-ING THE FRAMING OF RULES FOR ADMISSION TO THE PROVINCIAL File No. L.C. of EXECUTIVE SERVICE AND THE SUBORDINATE JUDICIAL SERVICE. 1913.

Under-Secretary -

1. The rules for admission to the Provincial Executive Service have already been published in the Gazette.—Vide Notification No. 3732-A, dated the 10th September 1912. Rule I of these rules lays down that only the natives of the province or persons who are already in Government service or whose parents are domiciled in the province, will be eligible for appointment to that service. The rule has therefore been so framed as is desired by the Hon'ble Member.

2. The rules for recruitment to the Subordinate Judicial service bave not yet been framed. The question was taken up in May last, and was discussed with Sir W. Duke at Darjeeling. At a conference of the representatives of the Government of Bengal and the High Court, which met in last August at Darjeeling, the Government of Bengal, undertook to revise their rules for recruitment to the Subordinate Judicial service, and a procedure for the prevention of the enrolment of undesirable candidates for that service was also decided upon. In October last, after the receipt of a copy of the record of the proceedings of the conference, it was decided that this Government after ascertaining from the Government of Bengal whether they had taken action on the lines agreed upon at the conference, should address the High Court on these subjects when they met after the vacation. In reply to a demi-official letter No. 176-T., dated 22nd January 1913, from Chief Secretary, Mr. Newbould has said that the Bengal Government rules have been revised and that the opinion of the High Court who have been consulted in the matter is being awaited and also that the procedure indicated at the conference is being followed by that Government.

A draft reply to the question is put up.

The rules for admission to the Provincial Executive Service were published in the local Gazettee of the 11th September 1912. Rule 1 provides that as a rule only persons who are natives of this province or permanently domiciled in it will be appointed.

The rules for admission to the Judicial Branch of the provincial Civil Service are now under the consideration of Government. In framing them the special claims of the residents of this province will not be overlooked.
