Appointment of Mr. L. C. Adami, I.C.S., Superintendent and Remembrancer of
Legal Affairs to the Government of Bihar and Orissa, as Secretary to the
Bihar and Orissa, Legislative Council.

Under-Secretary—

From page 10 of the Proceedings of the Legislative Council of the 20th January last it will appear that "the Secretary to the Council *for the time being*" is a member of the Select Committee appointed to consider the Orissa Tenancy Bill. It has been ascertained that the Select Committee will hold its sitting on the 20th instant. It is perhaps necessary to appoint Mr. Adami formally as Secretary to the Council before that date.

Upendra—17-2-1913.

The Legislative Rules are to be published under the authority vested in His Honour the Lieutenant-Governor by sections 37 and 48 of the Indian Councils Act, 1861. As soon as these rules are published they will have the force of law and it will be legal then to appoint the Secretary to the Council under rule 2(4) of those rules. We may thus give retrospective effect to the notifications if necessary, but until the Legislative Rules are published we cannot perhaps appoint the Secretary by a notification in the Gazette. The Legal Remembrancer may be consulted.

U. N. D.—17-2-1913.

Legal Remembrancer—

Would you kindly read the office note? Strictly speaking, the resolution appointing the Secretary to the Council for the time being to be a member of the Select Committee on the Orissa Tenancy Bill is incorrect for the Secretary is not a member of the Council (*vide* Rule 56(7) in which he is directed to assist the Council). It would have been more correct to say the Legal Remembrancer for the time being as it is in virtue of the office that you are a member of the Council. As, however, the Resolution stands, I think you should be gazetted as Secretary as soon as the rules are published.

M. G. HALLETT—17-2-1913.

The difficulty is that I am not a member of the Legislative Council and am not yet appointed Secretary, so I have no right to be present at the meeting, and, in fact no right to be at the Select Committee's sittings.

Perhaps the simplest plan would be to get me nominated in the Gazette in Mr. } A
Mullick's place, I could then, as a member of Council, act as its Secretary. As soon as the }
rules are published, I should be gazetted Secretary.
