THE deputation allowance of Rs. 100 a month sanctioned in Government order No. 578T.—San., dated 2nd July 1908, should really have been a *local* allowance, and not a deputation allowance, according to the precedent followed (*vide* Government order No. 924T.—San., dated 21st August 1907). The deputation allowance would, under Article 81, Civil Service Regulations, require India's sanction, but not the local allowance. We may inform the Accountant-General, that local allowance, and not deputation allowance, was meant and ask him to correct the orders accordingly.
