GRANT OF A LOCAL ALLOWANCE TO CAPTAIN FORSTER, I.M.S., ON SPECIAL DUTY IN CONNECTION WITH THE MALARIAL ENQUIRY IN BENGAL. [FILE S. D 1.] Nos. 1-2.] No. 960-D., dated Darjeeling, the 25th September 1908. From-Lieut.-Colonel F. C. Clarkson, I.M.S., Sanitary Commissioner, Bengal, To-The Secretary to the Government of Bengal, Municipal Department. I HAVE the honour to submit, for the favourable consideration and orders of Government, the accompanying copy of a letter, No. 56, dated the 17th instant, from Captain W. H. C. Forster, I.M.S., on special duty in connection with Malaria Enquiry in Bengal, requesting that, for the reasons stated therein, a local allowance of Rs. 100 a month may be granted to him under the provisions of article 32 of the Civil Service Regulations whilst employed on the above work. Although Captain Forster is about to leave the special work on transfer, the decision of Government on his application will not only affect him but his successor as well. No. 56, dated Calcutta, the 17th September 1908. From-Captain W. H. C. Forster, I.M.S., on special duty, To-The Sanitary Commissioner with the Government of Bengal. With reference to letter No 1470, dated Simla, the 22nd June 1908, from the Government of India to the Government of Bengal, authorising the payment to me, whilst on special duty under the Government of Bengal, authorising the payment to he, whilst on special duty under the Government of Bengal, of the same salary and allowances as I received in my last appointment, viz., pay as Officiating Deputy Sanitary Commissioner Rs. 750, plus a deputation allowance of Rs. 5 per diem, I have the honour to request that you may be pleased to represent my case to the Government of Bengal for favourable consideration.

(1) My last appointment was special duty under the Government of India for the investigation of dysentery. (2) The appointment was offered to me by the Government of India, and I accepted it on the understanding that my head-quarters would be in the Punjab; that I should retain my position on the Punjab list; and that I should revert to the Punjab establishment on the termination of my special duty. (3) On account of the expense necessarily incurred in moving from one province to another, and back again on the termination of the special duty, it would have been impossible for me—a married officer—to have accepted the appointment on the terms offered if a temporary change to another province had thereby been entailed. (4) The Government of India were pleased to give me the assurances I asked for. My head-quarters were located at Kasauli, Punjab. In their letter No. 1339, dated the 25th July 1906, to the Government of the Punjab (copy attached), the Government of India formally ruled that I should retain my position on the Punjab list, and revert to that Province on the termination of my special duty.

(5) Towards the end of my deputation with the Government of India, I received orders to the province of the control of the province of the p detailing me for duty in connection with the Bengal Malaria Enquiry, and at a later date a copy of letter, No. 1470, previously referred to.

(6) Whilst I am deeply sensible of the honour which has been conferred on me by the Government of India, in selecting me to conduct an enquiry to which great importance is attached, I wish to point out that in authorising the payment of salary and allowances at the same rates as that of my last appointment, the Government of India have placed me at a serious disadvantage. (7) The present appointment entails a move from the Punjab to Calcutta, and back again on the termination of my special duty. I need hardly say that for a married officer in receipt of my pay two such moves over a distance of twelve hundred miles, within a period of six months, will be a very serious matter.

(8) Whilst conducting the enquiry my time is shared between Calcutta, where the cost of living is very high, and the selected malarious tracts of Bengal which are admittedly unhealthy.

(9) In my work the risk to health is much greater than that ordinarily incurred by
the Rectardesical Department, and officers in this Department receive compensatory rates of pay. The pay and allowances granted to me are Rs. 100 a month, less than the pay and allowances of any officer of my service in the Bacteriological Department similarly employed. Such an officer would receive pay and allowances at the following rates, viz., pay Rs. 850 per mensem, plus a deputation allowance of Rs. 5 a day. (10) As further evidence of the inadequacy of the allowance granted to me whilst conducting the enquiry, I may point out that the Civil Assistant Surgeons working under me receive a special allowance of Rs. 100 per month, whilst my allowance is only Rs. 150 a

Under the circumstances, I have the honour to request that the Government of Bengal may be asked to take into consideration the facts which I have recounted, and to grant me a local allowance of Rs. 100 a month, under the provisions of article 37 (32?), Civil Service

Regulations, whilst conducting this enquiry.

With reference to your letter No. 983S., dated the 16th July 1906, I am directed to forward a copy of a Notification No. 1338, dated the 25th July 1906, placing the services of Captain Mackenzie, i.m.s., temporarily, at the disposal of the Punjab Government, and to say that Special Captain issued to him to report himself for orders, as possible, to the Sanitary Commissioner, Punjab. I am directed to refer to Mr. Monie's letter No. 1470, dated the 22nd June 1908, and the subsequent telegram from the Home Department, No. 1495San., dated the 25th July last, sanctioning the deputation of Captain W. C. H. Forster, I.M.S., to this Province for the purpose of conducting an enquiry into the prevalence of malaria, and fixing the pay to be drawn by him during the period of his deputation.

2. I am to submit, for the consideration of the Government of India, a copy of a letter No. 960D., dated the 25th September 1908, from the Sanitary Commissioner, Bengal, forwarding copy of a representation from Captain Forster, in which he applies for a local allowance of Rs. 100 on the ground that the pay already sanctioned is inadequate in the particular circumstances of his special duty.

3. In view of the nature and the importance of the work on which Captain Forster has been employed, and for the reasons urged by him in paragraph 9 of his letter of the 17th September, the Lieutenant-Governor desires to support his request; and I am to ask, therefore, that His Excellency the Governor-General in Council may be moved to sanction it. I am also to ask that the sanction, if accorded, may be made applicable to any other officer who may be appointed to succeed Captain Forster in conducting the special enquiry into the prevalence of malaria in this Province.

I am directed to refer to your letter No. 625T .- San., dated the 10th October 1908, requesting sanction to the grant to Captain Forster, I.M.S., of a local allowance of Rs. 100 a month in addition to his salary, and asking that the sanction, if accorded, may be made applicable to any other officer who may be appointed to succeed him in conducting the special enquiry into the prevalence of malaria in Bengal.

2. In reply, I am to say that the Government of India have no definite information regarding the precise nature of the work on which Captain Forster is engaged, but that they observe that the Government of Bengal originally proposed that it should be entrusted to an officer in its Sanitary

3. Captain Forster now receives pay as an Officiating Deputy Sanitary Commissioner, plus a deputation allowance of Rs. 5 a day, his total emoluments exceeding the pay of a permanent Deputy Sanitary Commissioner of his rank by Rs. 50 a month, and the Government of India do not think that he should be granted any additional remuneration, if his work is similar in character to that of a Deputy Sanitary Commissioner. If, on the other hand, it can be shown that his work requires special bacteriological qualifications and is beyond the scope of a Deputy Sanitary Commissioner, they will be prepared to consider the proposal further.

I am directed to acknowledge the receipt of Mr. Monie's letter No. 2308, dated the 7th November 1908, regarding the proposal made by this Government to grant a local allowance of Rs. 100 a month in addition to salary to Captain Forster, I.M.s., and to the officer appointed to succeed him, in conducting the special enquiry into the prevalence of malaria in Bengal.

2. It is stated that, as Captain Forster's present emoluments exceed the pay of a permanent Deputy Sanitary Commissioner of his rank, the Government of India do not consider that any additional remuneration should be granted if his work is similar to that of a Deputy Sanitary Commissioner. If, however, his work requires special bacteriological qualifications and is beyond the scope of a Deputy Sanitary Commissioner, the Government of India will be

prepared to consider the proposal further.

3. In reply, I am to say that the work on which Captain Forster is engaged is of the nature of original research, and requires an officer of the very highest attainments. It consists not only in ascertaining the existence of malaria, but in endeavouring to ascertain to what cause the large group of fevers in which the malarial parasite is not discovered is due. Such an enquiry can only be carried to a successful conclusion by an officer of considerable ability with special qualifications for bacteriological research work. The work is entirely outside the scope of the ordinary duties of a Deputy Sanitary Commissioner.

4. For the above reasons, and in the view of the fact that the officer has to work in very unhealthy areas, His Honour the Lieutenant-Governor desires to urge that the recommendation made in my letter No. 625T.—Sau., dated the 10th October 1908, may be favourably considered,

Grant of a Local Allowance to Captain Forster, I.M.S., on special duty in connection with the Malarial Enquiry in Bengal.

From the Sanitary Commissioner, Bengal, No. 960D., dated the 25th September 1908.

THE letter may be read.

As for Captain Forster's pay, while on special duty in connection with Malaria Enquiry in Bengal, please see India's telegram No. 1495S., dated the 25th July 1908. Captain

Forster entered upon his special duty in July last, and worked for two months only.

In their letter No. 1072, dated the 18th September 1908, the Government of India proposed to withdraw Captain Forster from special duty in this Province in the event of his services being required elsewhere, and we agreed on the understanding that another officer of like qualifications was sent to replace him. It may be noted here that in Government Order No. 572T.—San., dated the 2nd July 1908, sanction of Government was accorded to the grant of a local allowance of Rs. 100 a month to the two Civil Assistant Surgeons deputed to assist Captain Forster in his enquiry.

It is for consideration whether the present proposal to grant a local allowance to the

It is for consideration whether the present proposal to grant a local allowance to the special officer in question should not wait till Captain Forster's successor is selected by the Government of India.

As the Government of India fixed the pay to be drawn by Captain Forster, the question of granting him a local allowance may be referred to them. E. H. P.—2-10-1908.

It is not usual to grant deputation and local allowances at the same time and for the same work. Captain Forster has also been exempted from the operation of ten days' halt rule, so that he draws Rs 5 a day for halts outside his head-quarters.

It is doubtful whether the Government of India will favourably consider the application

for double allowance, but they may be inclined to recoup him the extra expenses on account
