To-The Secretary to the Government of Bengal, Municipal (Sanitation) Dept.

The Government of India observe that in the statements appended to the Provincial Vaccination Reports from all provinces, except Bombay, the total number of persons vaccinated corresponds with the total number of primary vaccinations and re-vaccinations. As in some cases, when the first vaccination fails, persons are vaccinated or re-vaccinated a second time, this fact suggests that, when the statistics are being compiled, the number of persons operated on is taken as the number of vaccinations, or vice versa. I am to observe that, if this is the case, the procedure is not correct, and I am to ask that, with the permission of the Lieutenant-Governor, instructions may be issued to ensure that in future an individual on whom a second operation is performed on account of failure on the first occasion is shown as one person only in the column showing the number of persons vaccinated, or re-vaccinated, and that when a second operation is performed on the same individual it is included in the total number of vaccinations or re-vaccinations, as the case may be, a footnote being inserted to explain the reason for the difference between the number of persons vaccinated and re-vaccinated, and the number of vaccinations and re-vaccinations.
