To—The Secretary to the Government of Bengal, Municipal Department.

I AM directed to state, for the information of the Government of Bengal, that the military authorities have suggested that intimation of the prevalence in an epidemic form of plague, cholera or small-pox in any district (or sub-division of a district) situated in areas from which men are usually recruited for the army should be communicated promptly by the civil authorities to all military divisions to enable Officers Commanding to prevent the dissemination of disease by men returning from furlough. It is represented that the present procedure which has been to rely on transmission by post of printed documents containing the required information has failed to secure the necessary promptness of notification.

2. As a means of securing this object, it has been suggested that Commissioners of Divisions (in which recruiting for the Indian Army is undertaken) might be instructed to telegraph weekly to the ten General Officers Commanding Divisions and the three General Officers Commanding Independent Brigades mentioned at pages 7 and 23 of the Army List for the quarter ending the 1st January 1911 what districts or sub divisions of districts within their jurisdiction are seriously infected with these three diseases within the ordinary recruiting areas of the Indian Army which are noted on the

margin. No blank returns, and no returns for districts outside these areas would be required.

3. By the adoption of these proposals more rapid and direct inter-communication between the Military and Civil authorities on this important point would be secured; and I am to request that, if the Lieutenant-Governor in Council see no objection, the necessary instructions to give effect to the procedure suggested in paragraph 2 of this letter be issued.
