Mizoramak kum 1966-a busina a lo chhuab atang khao, Mizoramah inman a tam ve ta hie a. Inman chhang ni lovin, rei fe fe inbreng te pawh a awm fo bawk a. Inman leh inbreng theihna dan, Mizorama hman mek, inman theih lohna dan telin, a langsar zual zual - India Dan pui (*Constitution*), Criminal Procedure Code (*Cr.P.C.*), sipaito thunehna (*Armed Forces Special Powers Act*), ram busi dan (*Assam Disturbed Areas Act*), leh dan lova chet kbpna dan (*Unlawful Activities Act*)-ahtha a lan dan, saplawng hrethiam loten bengvar lehzual nana an hman theih phab beiseina neiin leh chu chu tum berah neiin he lehkbabu te tak te hi ka buatsaih a ol. Heta dan (*Act*) hrang hrang ka rawn tarlante hi, a kip a kawia hrihfiah a ni lova, hriatthiam awl zawnga kaihawi a ni nuat blawm.

Heta number pek jbenkhatte hi chu, a dan bung leh chang ni lovin, thuhlawm htang htang (*paragraph*) number a ni blawm.

Tin, henga inman theihna dan tarlante hi, India rama inman theihna dan awm zawnge a ni lova, a dang tam tak a la awm blawm a; beta ka rawn tarlante hi chu, Mizorama langsar deuh deuhthe chauh an ni blawm.

Cbhiartuten hriat zau phah nana an hman ka beisei.

## Bung 1

India Constitution, Article 20 (1): "Mii eng tbil pawh lo ti sela, chu a tbiltih chu, a tib hun laia dan ding laiin, tbil sual tib anga a ngaih a nih loh chuan, chu a thiltih avang chuan thiamloh chantir theih a ni lo; tin, chu a thiltih suel avang chuan, a tibsual hun laia dan ding laiin hrem theibua dan a neih aia naa brem theih a ni lo." ("No person shall be convicted of any offence except for violation of a law in force at the time of the commission of the act charged as an offence, nor be subjected to a penalty greater than which might have been inflicted under the law in force at the time of the commission of the offence.")

India Constitution Article 245-ab chuan Parliament leh State Legislature te chu dan siam theitu ann i tun kau hmu a. Parliament chuan India ram pum huapin dan a siam thei a, State legislature chuan ama state huam chhung atan chauh dan a siam thei. Chung an dan siamte chu nakina hman turin emaw, hun kal tawh engemaw lai aṭang khan emawa nung turin a siam thei. Amaherawhchu a brema inbremania dan 'criminal law' erawh chu, hun kal tawh aṭanga nung tur anga siam theih a ni lo.

Entirna : 1. Vawiinah hian zu zawrh khapna dan lo siam ta ila, zu zuar apiang chu lungin tantir emaw chawitir tur emaw lo ni ta sela, tun hmaa lo zuar ṭhinte vawiin aṭanga zuar ta lotc kha chu he dan hmang hian hrem theih a ni lo, Art. 20 (1) hian a khap avangin.

2. Vawiinah hian zu zawrh khappa dan le siam ta iia, zu zuar apiang chu kum 2 emaw kum 3 enjaw tang pur lo ni ta selā, chu dan chu nikum atang khan hman tan turā siam theih a ni lo, Art. 20 (1) biao a khap.

3. January ni 1 thlenga dan ding lai chuan, zu zuar apiang lungin kum 2 tang turin a lo ti ta a. Chu dan chu January ni 1-ah siam that a lo ri ta a; January ni 1-a siam that (amend) ang chuan, zu zuar apiang chu lungin kum 5 tang turin a lo ti ta a. Hmeithai pakhat cku a zu zawrh avang-in January ni 1 bma lam khan man a ni a, rorel-tuin January ni 1 hnu laniah a chungchang thu a ngaihtuah ta a, thiāmloh a chantir ta a, lungin tang turin a rem ta a. Roreltu chuan kum 5 lungin tang turin a rem thei lo, kum 2 tang turin a rem thei a ni.

Amaljerawhchu, hremna buiam zawk siam erawh chu Art. 20 (1) biao a khap lo. Entiran, a chunga entirna kbi lo hmang leh ta iia: January ni 1-a dan ding lai siam that a ni h khan, kum 2 tang tura tih thin kha, kum 1 tang tura siam that lo ni ta thung sela chu. January ni 1 bmaa zu zawrh vanga man, man a nih bun laia bremna dan kum 2 lungin tan pawh lo ni se, dan siam that hnua a chung thu ngaihtuah a niha brem theihna dan chu kum 1 lungin tantir a ni.

“A thiltjh chu, a tih hun laia dan ding laiin, thil sual tib anga a ngaih” tih hian, thil sual apiang a huam thei lo. Zu zawrh chu thil sual ni mahse, zu zawrh khappa dan a awm bma chuan, miin zu zuar mahse, thil sual tia ngaih theih a ni lo.

Art. 20 (2) "Mi tumah thil tibsual pakhat avangin, vawi khat aia tam thubuaia siama hrem theih a ni lo." ("No person shall be prosecuted and punished for the same offence more than once.")

Mi, a thil tibsual avangin criminal court-ah hnuh lub lo niin, hrem ni sela, chu a thil tibsual avang suau hrem nawn leh theih a ni tawh lo. Amaberawh chu criminal court pawn lama hremna a huam tel lo. Entiraa: Sikul naupangin eula pawng sual seia, chumi avanga sikul hotum a naupang, nula pawng suau chungah chuan thununna lekin, sikul atangin naupang chu hnawt chbuak ta sela, chu chu 'bremna' anga chhiar theih a ni lo, court pawn lama bremna a nih avangin. Hnawhchhuah a nih abou hmanab, a oula pawngsual avang chuan, lungina kbung theib a la ni tho a ni.

Tin, heta 'thubuaia siam' tih hi criminal court-a thubuaia tblen tihna a ni a, civil court-a thubusia siam a kawk lo.

Tin, 'vawi khat hrem' tih bian hei bi a huam tel thei lo bawk. A chunga entiraa kan siam, sikul naupang khian, nula a pawng sual bakah tina ta bawk sela, a pawngsual avangin brem theih a ni a, a tibnat avangin brem theih a ni bawk Hei hi Art. 20 (2) bian a buam tel lo a ni.

Mi, tuu bmaa a thil sual lo tih tawh avangin court rorelnaa brem lo ni tawh sela, chu a thiltih sual avang chuan hrem leh theih a ni tawh lo chang ni lovin, thubuaia lak leh theih a ni tawh lo.

Art. 20 (3). "Mi, thll tisuala puh tumah, amah leh amah inbek zawnga thuhretua tang tura tibluib

theih a ni lo." ("No person accused of any offence shall be compelled to be a witness agatnst himself.")

Heta 'thil tisuala puh' tib bian, Indian Penal Code hnuaias brem theih chi thil tibsual (*riminal proceedings*) chauh a buam a, lungin tana inbremona chi ni lo (*civil proceeding*) a huam tel lo.

Tin, 'amah leh amah inhek zawnga thu bretu' atana tibluib theih a nih lohna dan bi, court bmaa a din hun chauh atan a ni lo va, thil 'tisuala puh' a nih aṭangin a hmang thei, bekna emaw First Information Report-a a hming a lan aṭangin, 'amah leh amah inhek zawnga' thu sawi luhtir theih loh a nihna, a 'right' chu miin a hmang ṭan ngbal thei a ni.

'Tib luib' tih bian, ama rilru puak chhuaka thu sawi lohtir theitu apiang, taksa emaw rilru emaw tibbrehawmsak a nib avanga ama rilru puak chhuak reng ni lova ṭawngtir a buam a. Thil tisuala puha chu chaw ngheitir emaw, vuak emaw avanga a thu-sawi emaw, inpuanna a neih emaw chu 'tib luib' a ni.

Tin, heta 'thubretu' tib bian ṭawngkaa a sawi leh a ziak a huam a.

#### Humhimna-nunna leh mimal zalenna laksak thush

Art. 21: "Mi tumah a nunna emaw a mimal zalenna emaw, danin a kālbmang a duan ang te lo chuan, chhuhsak theih a ni lo." ("No person shall be deprived of his life or personal liberty except according to procedure established by law.")

Hei hi mimal zalenna leh nunna khawih ching-pen sak emaw laksak emaw a nih lohna turā venna dan chu a ni. Tu zelenna luang mah dan ang te lo

chuan, da:sak theih a ni lova, tu nunna mah dan ang te lo chuan laksak theih a ni lo. Mi nunna emaw, zallen'a emaw laksak a nih dawo cuan, dann'i rahbi a tuksa rah kim vek piaxta ngat'a, dann'i a kawngthang a siam (*procedure*) zawn lovin tu zallen'a leh nunna mah laksak theih a ni lo.

He dan nian India khua leh tuite chung ni lovin, khua leh tur (*citizen*) ni lote pawh a huam tel vek a ni; tlamton chantira lungna tang lai (*convict*) te tlengin he humlinina dan bian ven chin a nei a ni, thiamtoh chantir' (*convict*) dan azir erawh a ni thung.

Tieta 'zallen'a' ub hian chin ten' nei lova zallen'a a kawk ther lo. Entiran: duh ang apiang sawi theihna zallen'a kan nei a, malse chu zallen'a chu 'dsu' vekin khap chin a nei a, chuti ni suh se inhrem tlanga kan awmna tur leh thil tha dang tam tak khawih pawi a nei ang. Khawiah pawh kal ther leh awm ther kan ni a, India ramah chuan, khua leh tuite chu: malse dan vekin chu chu khuahkhirhna chin a nei leh ve a ni. Entiran: Mizoramah chuan phai mi a duh apiangte on lo lutin an kbawsa thei lo, a dannna dan a awm avangin. Heng inkhuahkhirhna dan te hi chu he dan pui hian a huam tel lo a ni.

'Mimal zallen'a' (*personal liberty*) tiL bian a kawn dang leh chu, dan lo anga inhrem leh inkhuahkhirhna iaka zallen'a a ni. Mi, dan lo anga khung emaw khuahkhirhna emaw awm sela, Constitution Art. 226 hmangin 'Writ of Habeas Corpus' High Court-ah theh luha, brena awma chu chhuahfir tur a ni.

Tin, he bung leh change 'dan' tih hi, dan siam theitu pawl (*Parliament*) ia dan a siam chu a ni tur a ni a, Executive leh Department thuchhuakte a huam tel lo.

Emergency laim be dan Art 21 bi tibtawp ri (*suspend*) theih a ni a, chuianga suspend a lo nih chhung chuan, a chunga kan sawitak 'writ of habeas corpus' khi hman theih a ni lo, Art. 32 leh 226 te hi suspend ni ve kher lo mahse: avang chu ilawh-chban tur dan a awm iih loh lai a nih avangin. June 25, 1975 o emergency puau a lo nih pawh khan be Art. 21 hi che thei lova siam (*suspend*, a nih kha; khatih chhung khan he dan hmang hian dan lo anga brente chu Writ of Habeas Corpus hmanga chhuah thu pekna kawng a kaw lo a ni.

#### Humkiana-in man leh iahren thuh

Art. 22(1): "Man tupawh, man a nih chhante a rang thei ang bera hrilh a tih loh cauan, hren ngawt theih a ni lo; tin, ukil a duhzawng apiang a rawn leh chhantu atana a rawih khap sak theih a ni hek lo." (*No person who is arrested shall be detained in custody without being informed, as soon as may be, of the grounds for such arrest nor shall he be denied the right to consult and to be defended by a legal practitioner of his choice.*)

(2) "Mi tupawh, mana hren apiang chu, man a nib atanga darkar 24 chtutgin magistrate hnai bei hnena hruai tur a ni; manua hmun atanga magistrate court-a hruai huu chhung erawh chu chbiar tel tur a ni lo va, magistrate thu lo cauan darkar 24 aia rei

**tumah hren theih a ni lo.** ("Every person who is arrested and detained in custody shall be produced before the nearest magistrate within a period of twenty four hours of such arrest excluding the time necessary for the journey from the place of arrest to the court of the magistrate and no such person shall be detained in custody beyond the said period without the authority of a magistrate.")

Hetah hian thi pali pawimawh tak mana awm ten right an haun (*claim*) theihte kan hmu, chhu te chnu—

- (i) man chhante hrilh ngiat theihna right;
- (ii) a ukil dünzawng apiang biukrawn leh a man enhan tura rawn theihna; right;
- (iii) magistrate thupek lo chuan darkar 24 aia rei hrena awm loh theihna right.

Heng Kawegante hian 'right' a nei mai ni lova, a man len hrengtu chuan a man chhante a hrilh tur a ni a, kal chhung tiam lovin darkar 24 chhungin magistrate hnai ber haedah a hruat tur a ni a, magistrate thupek a awm loh chuan darkar 24 aia rei oren tur a ni lo. Tin, ukil rawn emaw rawn a duh chuan, chu chu khap sak theih a ni lo. Darkar 24 chhunga magistrate hmiaa thlen a nih lon chuan, chhuab ngual tur a ni.

Heta 'mana bren' tin hian ram dang mi (*alien*) thawn chhuah tura man leh bren a huam tel lo va, civil law bawheuhiat avanga man leh bren a huam tel bawk hek lo; thil sual (*criminal or quasi-criminal*) tia puh chungchang thua 'man leh bren' tibna a ni. Court ina bren tura a tib (*Judicial custody*) a huam tel bawk lo.

Mana awma chuan eng thil nge a tibsuala mana a awm, avang leh a chhan hre ngei khawpa hrilh a dawng tur a ni. Sap̄awng amik amak hre lo kha, man ni sela, sap̄awngin man a nih chhan hrilh ri ta sel", man a nih chhan briia ngaič theih a ni lo vang, lehlin sak a nih bawk si loh chuan. Lehlin sak pawh ni sela, ziaka briattir a ni tur a ni. Tin, man chhanchu chiang lo lutuk, court-a inven (*defend*) na tur fung pawh awm thei lo khawp a nih prei chuan a tira detention order-a hrim hrim kha thu tling lo (*void ab initio*) a ni.

Mana awma chuan, man a nih aṭangin lawyer a duh apiang a ru i thei a, court hmaa thu huai sawi dawn hunah chauh ni lovin, man a nih aṭang phatin lawyer a berawnin a ruai thei a ni. He a right hi hupbehsak theih a ni lo. A vengtu police-te chu awm ve zel mahse, an beng briat kher lovin a lawyer duh apiang chu a rawn thei a ni.

### **INPAWNG HREN**

**Inpawng hren** (*Preventive Detention*) : Hei hi thil tisual mai thei awma briatten, thil sual an tih loh phah theih nana ruahman a ni a, Constitution Art. 22, clause (3), (4), (5), (6) leh (7)-ahte hian a lang a. Inrinhlelhna leh thil tisual mai thei awma ngaihte man leh hrenna dan a awm loh chuan. leh chu dan chu hman atana Parliament-in a tih (*enforce*) loh chuan, Preventive Detention Constitution-ah a chuang e tih chbala tumah hren theih a ni lo.

Heng clause-ahte hian a lan danin, he Preventive Detention hi bnan theihna dan a lo awm chuan,

(1) Advisory Board a awm ang a, (2) chu Advisory Board-ah chuan High Court-a Judge atana ruat tling member an ni ang; (3) chu Board chuan bren (*detain*) rih tula a hriat loh chuan, Preventive Detention dana mante chu, thla thum aia tam hren theih an ni lo; (4) Board chuan thla thum ral hmawin hren rih zel a tul chhan, manna thupek siamtu thuneitu (*authority*) hnenan a report tur a ni; (5) chu manna thupek chu khin letna temchaung a rang thei ang berin a hawisak tur a ni. (6) Amaherawhchu, manna thupek siamtu chuan, vantlang hmakhua (*public interest*) tipawi thei nia a hriatte chu, a hrilh kher lo thei ang; (7) mahse man chhante chu hrilh loh chin pawh matna order siamtu chuan lo nei sela, thubuaia siama khin letna khawp tal a hrilh ngei tur a ni.

Amaherawhchu, Parliament-in, a duh chuan, (1) Advisory Board ngaihdan la hmasa lova thla thum aia rei hren theihna dan a siam thei a; (2) hren rei theih chin pawh a tuk thei a; (3) Advisory Board-in mante chu hren zel tur an nih leh nih loh a ensiah (*enquiry a siam*) dan tur hmangte pawh a siam thei a ni.

Kan sawi tawh angin, Preventive Detention bi 'thil a tisual e' tih avanga in manua dan a ni lo va, court hmaa firsiah ngam leh thiam loh inchantirna tling khawpa in charge-na awm mang si lo, man leh hren rih ngaiha lang site man leh hrenna dan a ni. Court hmaa thubuai sawi (*trial*) phei chu a cheng pha lo. Ram venhimna lam (*defence*) te, ram dang Rena inlaichinna (*foreign affairs*) te, li dia ram himna

(*security*) te, khawtlang tha tak leh tluang taka a kala-na (*maintenance of public order*) te, khawtlang tana chakkhai leh mamawb leh bna (*maintenance of supplies and services essential to the community*) te tih-buai leh chawhhoawka a awm lohna tura, chutienga che mai thei tura hriatte man leh brennu atana th chu a ni.

Parliament-in kum 1950 khan Preventive Detention Act of 1950 kha a rawn passed ta a. Mahse he dan bi kum 1969 khan tibtawp a ni a. A thlak nan dan (*Act*) pahnih Maintenance of Internal Security Act of 1971 leh Conservation of Foreign Exchange and Prevention of Smuggling Activities Act, 1974 te chu siam chhuah a ni a. Heng Acts pahnih-te hi Constitution 9th Schedule-ah dah a ni. Chumi awmzia chu, 'heng dan bian Fundamental right a kalb e' tia court-a khin (*challenge*) theih a ni lo. Heng danah te bian sorkar emaw thuneituin emaw bren chban hrilh kher loh leh ukil rawih theibna kawng hawnsak loh chu, khawtlang tana tha (*public interest*) nia a briat chuan, man chhan chu a hrilh lo thei a, ukil rawih theibna kawng pawh chu a hawn sak lo thei a ni, Mantu leb hrengtu chuan, thil ti dik lo deuh pawhin lang mah sela, he dana mante chuan 'Fundamental right a kalb e' tiin court-ab an kal thei ta lo a ni.

Heng kan ban sawi tak zawng zawng te hi India Constitution-in 'right' min pek tam takte zingab pawb, a hlu zual deuh anga cheibawl, a hnunpui 'Fundamental right' a tihte zing ami a ni hlawm a.

Chumi əwmzia chu, India kbua leh tui tupawh ina right tam tak kan neihte zinga a bulpui leh pawimawh bikte zing ami a ni hlawm a. Heng right te bi, tu lakah pawb tihchingpen emaw khawih khaw-joh sakin emaw lo awm sela, Constitution Article 32 hmangin Supreme Court-ah emaw, Article 226 hmangin High Court-ah court bnuaihnung zawkte kal tlang lovin a kal nghal theih a ni. Supreme Court emaw High Court emaw chuan, a tul dan azirin, direction emaw order emaw, writ chi hrang hrang-habeas corpus, mandamus, prohibition, quo warranto, certiorari, a eng bera emaw hmangin a lo chban dawn a ni.

Heng fundamental right-te hi Emergency puan a nih chuan, Presidnet-in Art. 359-a a thuneihna hmangin a titawp rih thei. Kum 1975-a emergency puan a nih pawh khan heta kan sawi Art. 21 leh 22 te hi tihtawp rih (*suspend*) a nib kha. Hetianga suspend a nih chhung hi chuan, 'fundamental right' suspend apianga kha awm lo ang a nih avangin, Fundamental right inkhawih pawisak avangin, court-ah kal theih a ni lo, emergency bilih a nib bnuah pawh.

**Bung 2**

**Parliament member-te leh State Legislature-a  
memberte zalenna leh hum an nib dan**

Parliament member-te chuan, Parliament chhung-ab chuan dub dub sawi theibna zalenna an nei a. Parliament-a an thusawiah emaw, an vote pekah emaw Parliament-in Committee a siama an thusawi-ah emaw an vote pek thuah emaw court-a khin theih an ni lo. Chumi awmzia chu. Parliament-ah emaw, Parliament-in Committee a siama an thusawi leh vote pek chu, tute tan emawa hmingchhiat thlak tak pawh lo ni sela, tihhmingchhiat man court-ah an thing thei lo a ni. Tin, Parliament-in phalna a pek tupawhin, Parliament-a thungaiantuah leh lehkha, report leh an vote pek dan te lo chhuah mahse, a chhuah tute chen chuan khin theih an ni lo a ni. (*Const. Art. 105*).

State Legislature-a member-te kumbalhna leh zalenna pawh, Parliament memberte zalenna ang bawkin a sang hle a ni. Rorelna in (*House*) chhung-ab leh Committee a siam (*Estimates Committee, Committee on Privileges etc.*) tea an thusawi leh vote pek thuah khin theih an ni lo; Parliament member-te ang bawkin, tihhmingchhiat man court-a khin theih an ni lo. Tin, House-a report, paper, vote leh thungaiantuah pawh, House phalnaa chhuah a nib chuan, a chhuah tute chen chuan danin a hum a, court- a khin theih an ni lo. (*Const. Art. 194*). Fundamental right, Const. Art 19 (1) (a)-a duh duh sawi theibna zalenna kha anni chuan a famkimin House chhungab

chuan an hmang thei tibna a nih chu. Duh duh sawi theihna zalenna chu nei m ah ila, chu kan zalenna chuan midangte zaleenna emaw pawin a emaw a khawih erawh chu a thiang lo; chu dan chuan M.L.A-te chu House chhunga an sawi a nih phawt chuan a pbuar ve lo a nih chu.

Amaherawhchu, Supreme Court leh High Court-a roreltu (*Judge*) ten, an tibtur (*duty*) an tih chungchang thua an thiltih dan (*conduct*) erawh chu an sawi thei lo thung a ni (*Const. Art. 211*). Hemi chungchang thu hi chu Parliament pawhin sawi theihna a nei bik lo va, amaherawhchu Judge-te chawlhtir (*ban*) thu erawh chu danin a zam anga sawi theihna an nei a ni (*Const. Art. 121*).

Tin, Parliament leh State Legislature chuan, an kalmang (*rules of procedure*) an siam thei a, chu an rules leh procedures siam chuan, M.P leh M.L.A-te zalenca chu khuabkhirh chin a nei thei a ni (*Const. Art. 118,208*). Constitution in thuneihna a pek angin, Mizoram Legislature atan bik 'Rules of Procedure and Conduct of Business in Mizoram Legislative Assembly' chu siam a ni. Tichuan, M.L.A tupawh man lo ni sela, emaw lungina dah emaw lo ni sela, a thu latu Magistrate emaw Judge emaw chuan Speaker hnenat man a nih chhan te, manna bmun te engkim a rang thei angin a thlen tur a ni. Tin, Speaker phalna lo chuan House hungchhungah mi man theih a ni lo, court lam thuchhuak pawh inblan theih a ni lo.

### Bung 3

Criminal Procedure Code-ah hian inmanna dan chu a chuang tam viau va, India Constitution Article 21-ah chuan mimal zalenka bumsakin a awm a- "Mi tumah a nunna emaw a mimal zalenka emaw, danin a kalhmang a duan ang te lo chuan, chhuhsak theih a ni lo" tib ziak kan hmu a. Phek hmasa lam- ah pawh kan sawi tawh kha.

"Danin a kalbmang a duan ang te lo chuan" tib a nih avangin, Criminal Procedure Code hian a dan kalhmang engkini chu a rawn duang chhuak ta a ni. Inman bian mimal zalenka a tibo a, dan ang lova inman phei chu thil thieng a ni lo va. Mahse danin man tula a ngaihte chu danin a ruahman anga man theih aο ni a. Inman a tul chhan chu - Court emaw dan kengkawbhu officer hmaa lantir theihna atan a ni.

Tin, heng thuneihna hmang theitute hian he an thuneibna (*tihchhiat theihna*) an neih hi, ‘an ngaihdina tihchhiat tul nia an briat chuan, an hmang thei a ni.

**Thuneitute humna dan:** He dan hnuaja thuneitute hi an thuneibna bmanga thil an tih achungah State sorkar phalna la hmasa lo chuan, khia theih an ni lo, Criminal court-ah pawh Civil Court-ah pawh.

## Bung 5

The Unlawful Activities (Prevention) Act, 1967

(Act No. 37 of 1967)

1. He dan bi The Unlawful Activities (*Prevention*) Act, 1967, "Unlawful Activities" tia kan koh thin hi a ni a. Pawl (*association*), he dan ina a khap tlinga a ruat apiang khapna dan a ni.

He dan ina pawl dan kah (*unlawful association*) a a ngaihte chu-

(i) eng pawl pawhin, eng vang pawha India ram bung khawilai pawh, India ram (*Indian Union*) atanga lakhran tumna a neih chuan, emaw chu pawl chuan mimali pawh, pawlho (*group of individuals*) pawh chu tumna chu a neihfir phawt chuan;

(ii) eng pawl pawhin India ram amaha ro inrel theihna a neih (*sovereignty*) leh India inpumkhatna (*territorial integrity*) hi hnialna (*duh lohna*) leh tih-chingpen leh tibbuaina a neih emaw, tumna emaw a neih chuan, chu pawl chu dan lova che (*unlawful activity*) nia ngaih a ni.

Heta 'dan lova che' tib hian, a tiha tih emaw, a sawia sawi emaw, chhinchhiahna (*sign*) emaw, mita hmuh theiha a lem siam emaw te a huam vek a. Chumi awmzia chu thiltihin, thuin, ṭawngkamin, ziakin, chhinchhiahnain emaw mita hmuh theiha a lem siamin emaw he dan hi a bawhchhiat theih tibna a ni.

Fiah zawkin beraang hian sawin lo tum teh ang; tekkhin nan : He kan rama Y.M.A. hi pawl (association) a ni a. He pawl hian India ram bung khawi lai emaw hi India ram atanga sabthlak lo tum ta sela, emaw India ram mahnia ro inrel a nibna leh inpumkhatna (*sovereignty and integrity*) hi tihchiat lo tum ta sela, chu Y.M.A. chu he Unlawful Activities Act hian 'dan lova che'ah a ngai dawn ta a; dan lova chea a puh theihna chu, chu Y.M.A. chunn, emiaw chu pawla tel tena an thiltih, emaw an thu-ziak emaw, an thusawite chu a ni.

**2. Dan lova che-a puu dan:** (i) Central sorkar n a ngaihdanin, eng pawl pawb dan lova c'e-a "ngaih chuan, sorkar chanchinbu (*Official Gazette*) a briattirna (*Notification*) chhuahin, chu pawl chu dan lova chea puuin dan pawn a hnawlna thu a chhuah ang.

(ii) Chu sorkar thuchhuak chuan eng vanga dan pawn a hnawlna nge a nih, avang leh a chhan leh tul a tih dangte nen a tarlang tel tur a ni a; amah-erawh chu mipui vantlangte tana briat atan tha lo a tibte chu a tarlang kher lo thei bawk.

(iii) He dan hmanga kut lek theitu pawl Tribunal siam a ni tur a ni a, chu Tribunal chuan, chu sorkar thuchhuak chu thupek (*order*) siama nemnghehna a siam a, chu a nemnghehna thupeka chu soakar chanchinbu chhuah a nih bma chuan, sorkar thuchhuah chu thu tling a ni thei lo.

Amaherawhchu, Central sorkar chuan dan lova chea a ngaih pawl chu dan pawnna hnawl nghal vat tul riaua a briata, tul riaua a briat chhan cku ziak ngeia a tarlan bawk chuan, sorkar chanchinbua a conuah ni atangin thi thay, hman nghal theih a ni ang.

(iv) Dan pawnna hnawl a nih thu sorkar chanchinbua chhuah bakab, nitin chanchinbu pakhat aia tamah chhuah a ni bawk tur a ni. Chung chanchinbute chu dan pawnna hnawl pawl awm na rama sem darh ve chanchinbu a ni kher tur a ni a, chutiang ang pawl hnenah chuan theih a nih chuan a copy pawh pek bawk tur a ni. Hriat zau theihna dan tur kawng nia sorkarin a briat ang apiang hmangin a theh darh theih bawk.

3. He dan bi India ram puma hman tur atana Parliament dan siam a ni. India ram khawiah pawh he dan ina dan pawnna hnawl ting nia a puh a awm chuan, chu pawl lakah cnuan he dan hi a hmang emaw, a hmang thei emaw tihna a ni. India ram khawiah pawh dan lova chea puh thei leh dan pawnna huawi ting pawl a awm loh chuan, he dan hi chulai ramah chuan awm lo ang a ni. Meghalaya-ah chuan dan pawnna puh theih pawl a awm loh avangin, Meghalaya-ah chuan he dan bi awm lo ang a ni. Awm lo ang a nih avangin, he dan hian Meghalaya a huam tel lo tihna a ni chuang lova, Meghalaya atangin he dan bi sut a ni tihna pawh a ni chuang hek lo. Dan pawnna chea puh theih tur pawl a awm

loh avang chauhvin, Meghalaya-ah hman loh tihna chauh a ni.

He dan hi India ram bnug khawilai emawa hman loh tura Parliament-in siam thatna (*amendment*) a siam a nih ngawt loh chuan, a chunga kan sawi tak ang bian, India ram pumah ang kbat veka khawiah pawh hman a ni. Dan thenkhat chu ram chhung khawilai emawa duha hmana duba hman loh chi te a awm a, chutiang chi chu chulai ram atanga sut a sut loh theih a ni. He dan hi chutiang chi chu a ni lo.

4. Eng pawl pawh dan pawnna hnawl a lo nih tawh chuan, sum leh pai a kawlte chu Central Sorkar-in hman (*dehral*) a phal lo thei a ni. Tin, Central Sorkar vek chuan, chung pawisate chu khawi atanga hmuh nge a niha, enga tan nge hman an tum tih te leh kawl dang an la nei em ? tib te leh sum ziakna bute ena dap chhuak turin Gazetted Officer a ruat thei.

Hetianga sorkar thupek chungchangah hian miin lungawi lohna a neih chuan, sorkarin thupek a siam ni atanga ni 15 (sawmpanga) chhungio, lungawi lohna neitu chenna bmun chunga court thuneihna neitu District Judge hnenah a thlen thei a, chu District Judge chuan thu chu a rem ang.

5. (i) Central Sorkar-in khawilai bmun pawh dan pawnna hnawl pawl ina hman atana a hman bmun dia a briat chuan, chu bmun chu 'Dan pawnna hnawl pawlin a hman bmun' angah a pueng thei a ni.

Heta 'hmun' tih hian in pumpui emaw a then azar (*pindan thenkhat chauh*) emaw puamin emaw lawng emaw a buam tel.

(ii) Chulai 'hmun' a deh chet theih thilte, incheina thil, bungbel, khum leh puanthuah, hnathawhna hmānrua, ran, buhhum leh ei leh bar tur thil leh nepnawi dangte tiām lovin chulai hmuna thuneitu District Magistrate chuan, emaw a aiawh tura a ruat Officer apiang chuan thuhretu pahieh nejin a chhinchhiah vek ang.

(iii) District Magistrate chuan, chung a thil hmuhte chu tumahina an hman a remti lo thei a, chu hmun chu tlawh emaw luah emaw a khap thei.

(iv) Police Officer, Sub-Inspector aia te loin emaw, Central sorkarin mi a ruat apiangin emaw, cnulai hmuna lut, emaw luh tum, emaw awm emaw apiang chu a dap theibna turin a khuahkhirh (*detain*) thei a ni.

Dap nagaia a briat cāu hmeichhia a nih chuan, hmeichhia vekin a dap tur a ni.

(v) Miin lungnih lohna a neih chuan, sorkar-in thupek a siam atānga ni sawmthum chhungin District Judge thuneihna hmang theitu Court-ah a thlen thei a ni:

(a) Chulai hmun chu 'Dan pawna hnawl' pawl tana hman a nih loh thu puang turin a ngen thei a,

(b) Tumah chulai hmuna lut emaw cheng emaw thei lo tura thupek a lo siam tawh sut turin a ngen thei bawk.
