By order of the Government of Assam in pursuance of all India legislation it is hereby directed that no extension of Tea cultivation may be permitted on my account till further orders in writing.

This order is necessary as Tea growers throughout the Empire and other countries have agreed to a scheme by which the Tea placed on the market is sufficient to meet the demand by buyers for sale at a rate which permits the labourer a fair wage, but any excess of supply over demand would result in unsalability and a consequent reduction in sale price which would result in thousands of tea labourers families being faced with starvation.

STANDING ORDER No 11 of 1936—37.

Office of the Superintendent, Lushai Hills.

Order for proclamation by beat of drum by Circle Interpreters concerned.

1. Within 5 miles radius of Aijal anyone found in possession of distilled Zu on his person or in his house or of any apparatus used for distilling will be prosecuted and severely dealt with.
2. The practice of conveying ordinary Zu from one village to another anywhere within the 5 miles radius of Aijal for any purpose whatsoever is prohibited and contravention of this order is punishable — except in the case of one bottle for personal consumption only.
3. The owners of houses in which any breach of the peace arises as a result of drunken brawls will be held personally liable and chiefs who have permitted such a state of affairs without taking steps to hold the party concerned responsible will themselves be held to be liable.

This area is an artificially populated one with a concentrated population and the above orders are passed for the purpose of preserving the general peace of the community and to emphasise the need for temperance and moderation. The Lushai would dislike being called uncivilised. In all civilised countries drunkenness causing a breach of the peace and a disgrace, not drinking of alcohol... is an offence punishable with jail.

The following Resolutions have been passed.

Resolution No. 1.

Nursing.

The Committee desire steps be taken to recognise officially the right of English Nursing sisters as approved by Civil Surgeon Lushai Hills at Durtlang and Sawkawn to grant Certificates valid for Lushai Hills only of competency in Mid-wifery and general nursing after a 3 years practical course actually working under these sisters. The grant of these Certificates would be subject to approval of Civil Surgeon given after a set examination by a District Board consisting of Civil Surgeon, Lushai Hills, Dr. Williams Welsh Mission and one Nursing sister.

The District Red Cross Committee will offer Rs 6/- per month subsistence allowance per probationer under training for 8 years for 4 Nurses. It must be understood when calling for applicants that the District Red Cross Committee can not promise any post after training the availability of which will depend on the grant by the Provincial Red Cross of Rs 15/- per Nurse for service in out-villages.

But in selecting applicants chiefs of villages will be asked to undertake that if such posts cannot be financed by the Provincial Red Cross Committee the village undertakes to accept back the Nurse if she gets her Certificate, on a subsistence allowance of around Rs 28-0 worth of rice monthly and maintenance of a house till she gets married after which the subsistence grant by the village of Rs 28-0 worth of rice only will continue.

RESOLUTION No. 2.

Provincial Red Cross Committee be moved to finance three Nursing sisters for immediate employment in the Civil Hospital at District Headquarters on a pay which need not exceed Rs 20. This is really necessary as there is not even one Official Nurse at this District Headquarters' Hospital which deals over 80000 cases a year.

RESOLUTION No. 3.

Let Red Cross Sub-Committee be formed at places where a Dispensary already exists.

Let the Doctor, Circle Interpreter where there is one chief, Teacher, Paster or Evangelists all be asked to serve on the local committee.

RESOLUTION No. 4.

The District Red Cross Committee would urge on the Provincial Committee that as this District is poor and without means of increasing its monetary resources we may be given assistance proportionately in excess of that to which large and wealthy cities might feel themselves entitled as after all such areas possess the means to implement this welfare work.
